



TRAINING PROVIDER CIRCULAR NO. 3/2006
EXEMPTION FROM ATTENDING "TRAIN THE TRAINER" PROGRAMME UNDER THE
NEW PROCEDURES OF TRAINING PROVIDERS

1. OBJECTIVE

- 1.1 This circular is to inform all training providers registered with PSMB regarding the exemption to attend the "Train The Trainer" programme under the new procedures of training providers No. 2/2006.

2. BACKGROUND

- 2.1 PSMB had introduced new terms and conditions for the application of training providers registration certificates under the Training Provider Circular No. 2/2006.
- 2.2 Training Provider Circular No. 2/2006 as per 5.1.1 (d) states that all trainers of training providers registered with PSMB are required to attend the "Train The Trainer" programme as one of the conditions for the registration and renewal of training providers certificate.

3. EXEMPTION FROM ATTENDING "TRAIN THE TRAINER" PROGRAMME
UNDER THE NEW TERMS AND CONDITIONS OF THE NEW TRAINING
PROVIDERS CIRCULAR 2/2006

- 3.1 PSMB has given the exemption to trainers of training providers who possess one of the following certificates or qualifications:-
- a) Teacher Training Certificate from Government Teacher's Training College;
 - b) Diploma in Education from recognized government institution;
 - c) Trainer Certificate from Center for Instructor and Advance Skill Training (CIAST);
 - d) Vocational Trainer Certificate endorsed by Majlis Latihan Vokasional Kebangsaan (MLVK);
 - e) Bachelor in Education from Universiti Perguruan Sultan Idris (UPSI), Universiti Sains Malaysia (USM), Universiti Islam Antarabangsa Malaysia (UIAM), Universiti Kebangsaan Malaysia (UKM), and Universiti Teknologi Malaysia (UTM);
 - f) Master in Education from Universiti Perguruan Sultan Idris (UPSI), Universiti Sains Malaysia (USM), Universiti Kebangsaan Malaysia (UKM), Universiti Malaya

(UM), Universiti Putra Malaysia (UPM) and Universiti Teknologi Malaysia (UTM);

g) Certificate in Training and Development (CITD); and

h) Certified Training Professional Certificate (Institute of Training and Development)

3.2 The exemption is also given to trainers who have earned the title of Professorship from the Institution of higher learning.

4. CLOSING

4.1 With the exemption given above, it will improve the effectiveness and quality of training delivery.

4.2 The Training Provider Circular No. 3/2006 will take effect on 19th April 2006.
